1 BID INVITATION

Bids are hereby invited from suitably qualified and experienced Contractors for the construction of Project as indicated on the table below within Ingwe Municipality (KZ5a1). The Sports Field should be constructed to meet the department of sport and recreation and Ingwe local Municipal Standards. Only bidders with a CIDB Grading as indicated on the table will be considered in the adjudication process. The adjudication of the bids will be done in terms of the Preferential Procurement Regulations, 2011 Pertaining to Preferential Procurement Policy Frameworks Act, 2000 (Act No. 5 of 2000) and will be based on the 90/10 points system, points will be awarded as follows 90 – Price and 10 – BBBEE status.

This is a Municipal Infrastructure Grant project, which has to address LED and EPWP requirements; therefore contractors must show compliance of the above in their proposals.

The meeting point for the site inspection will be at Ingwe Municipality offices in Main Street, Creighton. Representatives from the Consultants' firms and Ingwe Municipality will meet prospective Bidders to provide details of the Contract, thereafter proceeding to the site.
