



## BID NOTICE

### 1 BID INVITATION

Bids are hereby invited from suitably qualified and experienced Contractors for the construction of Projects as indicated on the table below within Ingwe Municipality (KZ5a1). The Community hall must be built to the Ingwe Standards and NHBC standards and the Sports Field must be built to Sports and recreation sand Ingwe Standards. Only bidders with a CIDB Grading of indicated below in the table will be considered in the adjudication process. The adjudication of the bids will be done in terms of the Preferential Procurement Regulations, 2011 Pertaining to Preferential Procurement Policy Frameworks Act, 2000 (Act No. 5 of 2000) and will be based on the 90/10 points system, points will be awarded as follows 90 – Price and 10 – BBBEE status.

This is a Municipal Infrastructure Grant project which has to address LED and EPWP requirements; therefore contractors must show compliance of the above in their proposals.

### 2 COMPULSORY SITE INSPECTION

The meeting point for the site inspection will be at Ingwe Municipality offices in Main Street, Creighton. Representatives from the Consultants firm and Ingwe Municipality will meet prospective Bidders to provide details of the Contract, thereafter proceeding to the site.
